The current landscape within the financial industry in recent years showcases a remarkable trend: the number of foreign residents in Japan, likely engaged in activities such as overseas remittances, has soared to 3,223,858 individuals as of the end of June in 2023, marking a significant increase of 148,645 people, or 4.8%, compared to the previous year (as announced by the Immigration Services Agency of Japan on October 13th, 2023).

Furthermore, according to the data from World Bank (Migration and Development), the global remittances by overseas workers, especially remittances to low- and middle-income countries (LMICs) surged to \$626 billion in 2022, representing a notable 5% increase.

In 2022, Asia witnessed a significant influx of new overseas workers, totaling 4,642,000 individuals (as per reports from the Asian Development Bank Institute, Organization for Economic Co-operation and Development, and International Labor Organization). This figure approaches pre-pandemic levels, highlighting the resilience of this sector.

Notably, remittances from overseas workers to emerging and developing countries serve as a crucial source of foreign funding, surpassing both foreign direct investment (FDI) and official development assistance (ODA). These funds play a pivotal role in supporting personal consumption and capital investment in destination countries, underscoring their importance in bolstering economic growth and stability worldwide.

The company, which provides the overseas remittance service "PayForex" (launched in 2011, currently available for remittance to over 200 countries and regions) has committed to the demand of remitting to Asian countries and other emerging and developing countries. And the service is largely utilized by the foreign residents.

Through the participation in this event, the company aims to solidify partnerships with banks and financial institutions within Asian countries, further strengthen and expand our remittance network. With a focus on providing enhanced remittance services to all individuals, including global workers and students residing in Japan, the company is committed to proposing initiatives for the improvement and modernization of nation's financial infrastructure.

PayForex provides 24-hour online remittance service to more than 200 countries and regions worldwide in more than 40 currencies. Customers can complete the entire process online from registration to transaction request. Compared to traditional remittance methods, PayForex offers low-cost remittance fees and protects customers' funds through the performance security deposit based on the Payment Service Act.

[Features]

• Fast Deposit

Generally, the fund will arrive at beneficiary's local bank account or e-wallet balance quickly after completing the remittance procedure. (Remittance usually takes 1-3 business days when using a bank)

• Remittance fees

Remittance fees vary from $0 \sim 2,000$ yen which is lowest level in the industry. And once the remittance amount exceeds the equivalent of 600,000 yen, it is free of charge.

• Fund Safeguarded

PayForex is regulated by Security Deposits system defined in Payment Service Act, thus customers' fund will be well secured.
